## Habitats and Habitus: Politics and Aesthetics of Religious World-Making

ZMO, Berlin 11/12 January 2013

Convened by Kai Kresse (ZMO/Columbia) and Birgit Meyer (UU/ZMO)

This is the first workshop organized in the framework of the Habitats and Habitus research program. One of the central concerns of this program is to develop a conceptual framework that allows to study Christianity and Islam within one field. This concern is grounded in the recognition that the plurality of the religious field - in Africa and elsewhere - in which Christians and Muslims (and practitioners of other religious traditions) coexist calls for more encompassing concepts, approaches, and methodologies.

The workshop will consist of 4 panels. In the first panel, we will critically reflect on the anthropologies of Islam and Christianity: what are the central concepts developed with regard to the study of these religious traditions? What are significant differences, what are common themes (especially regarding issues of ethics and self cultivation)? How could these respective anthropologies be synergized within a larger anthropology of religion? How useful or limiting is it to taken "religion" as a common ground? The second panel will feature researchers who are conducting research on Christians and Muslims in one framework (in Africa and elsewhere). What are the problems encountered in doing so? What are the gains and potentials? The third panel will concentrate on the future research of the two PhD students in the Habitats and Habitus project. Both will present their research projects. The aim of this panel is to give them feedback. The fourth and last panel will go deeper on issues of religious diversity in city, discussing the historical developments and social dynamics of urban space as negotiated among and between different kinds and groups of inhabitants, with a view to faith and other relevant issues.
